Terms & Conditions of service shall be as follows:-

01.	Eligibility	Should be an MBBS Doctor with appropriate registration, preferably with MD/MS with at least 1 Years experience in government hospital / reputed private hospital.
02.	Age	Should not have attained 60 Years of age on the day of publishing of this advertisement.
03.	Days and duration of visits	At least thrice in a week or every alternate day. Time will be communicated later.
04.	Location of the Dispensary	Main campus of ICAR-NIBSM, Baronda, Raipur
05.	Remuneration	Rs.25,000/- (lumpsum including transportation) for MBBS Rs.30,000/- (lumpsum including transportation) for MBBS+ MD/ MS
06.	Conditions of service	Purely on contract basis initially for a period of one year and extendable for further period, or till further orders whichever is earlier.



Latest by 16.07.2022, along with self-attested copies of qualification, work experience certificate, address proof, 2 passport sized photographs, etc. The contractual engagement shall be further subjected to the following terms conditions:

Additional Terms and Conditions:

1. The Doctor is responsible to treat the employees / pensioners/ students of the Institute by prescribing medicines for common diseases for which he/she will be assisted by a contractual employee etc be provided by the institute.
2. All Medical Claims of the employees/ pensioners/ students who have taken treatment from him/her to be countersigned by the doctor engaged on contract basis.
3. He/She will be the authorized medical attendant for the employees/pensioners/ students during his/her tenure as Part -Time Medical Officer.
4. The right to accept or reject the applications without assigning any reasons thereof rests with the Director NIBSM. The Competent Authority reserves the right to terminate the contractual engagement of the Part -Time Medical Officer even before the expiry of tenure.
5. The Doctor shall not be entitled to any other benefit like Provided Fund, Pension and Gratuity, Housing etc. or any other benefit available to the Govt. servants appointed on regular basis.
6. The Doctor will not have any claim or right for regular appointment to any post under ICAR- NIBSM.
7. Only Consolidated remuneration will be admissible. No dearness allowance or any other allowance will be admissible to the Doctor.
8. The Doctor is not entitled to any TA for joining at the place of posting on accepting appointment.

9. The Doctor is supposed to countersign the records maintained at Dispensary (OP register, other stock registers).
10. He/She will be authorized medical attendant for issue of medical certificate of illness/fitness for leave on medical grounds after his/her careful examination of the staff.
11. The application may be sent to this Institute on or before 16.07.2022 by 03.30 PM and the application received after the due date and time will not be entertained.
